II. Associates Admission Procedure

For admission as an Associate of the Chamber, a Company or a Firm shall make an application in writing to the Directors of KCCI on the prescribed form, which shall be duly signed by all participants. The applications shall contain an acceptance of, and an agreement to abide by, the rules and regulations of the Chamber.

Note : The final decision regarding the benefits depends on the Board of KCCI

GST (Goods and Services Tax) 18% is applicable on the annual subscription amount.

- ✦ An 18% GST (Goods and Services Tax) is applicable on the annual subscription fee.
- ✦ Annual renewal of membership falls due on 1st April each year. Members must submit their latest Gross Sales Turnover details to KCCI.
- ✦ From the second year onwards, Patron Associates are required to pay an annual fee of INR 25,000/-.
- ✦ For International Associates, an additional one-time fee of USD 100 plus applicable taxes will be charged.

The student can associate by fulfilling one of the below criteria.

- ✦ Those who have passed 10+2 academic program and are enrolled in a degree course either full-time or part-time at accredited educational institutions and carrying at least 30% of a normal full-time academic program.
- ✦ Those who have passed 10+2 academic program and are pursuing diploma courses approved by State Directorate of Technical Education
- ✦ Those who have passed 10+2 academic program and are pursuing a course in a non-formal institution
- ✦ Those graduates pursuing a course in areas of interest
- ✦ Those who are student members of any technical or scientific society

Associates Subscription is calculated on the basis of calendar year (April - March)

Membership is valid for one year from the date of approval and is renewable annually. Renewal must be completed within the stipulated time to maintain active status.

V. Associate Involvement Structure

It is important that all associates are aware of and take full advantage of the services provided. After receiving associate feedback, only the KCCI Board has the authority to develop and introduce any new services.

District : The first level of participation is at the District level where associate can participate in the District Councils and other District activities.

State : The second level of participation enables Associate to participate in State Councils, which determine the official policy on State issues.

Region : The third level of participation enables Associate to take part in the Regional Council, whose members have the final say on all policy matters affecting the Region.

National : KCCI National Committees play a vital role in India's economic and industrial development, providing guidance on national policy & strategic initiatives.


International : KCCI International Committees play a crucial role for Bilateral trade and facilitating Global expansion.

Guidelines

- ✦ **Eligibility :** Open to businesses, professionals, and organizations aligned with Chamber's objectives.
- ✦ **Application :** Membership is subject to approval by the governing body.
- ✦ **Fees :** Annual membership and registration fees must be paid timely.
- ✦ **Conduct :** Members must adhere to ethical business practices and the Chamber's code of conduct.
- ✦ **Participation :** Active involvement in Chamber activities is encouraged.
- ✦ **Termination :** Membership may be revoked for misconduct or non-payment of dues.
